The Northland CAPS program in Kansas City is a profession-based learning approach where students are fully immersed in the business community, treated as professionals and participate in real projects, using industry standard tools with real business partners. Students gain professional skills in high demand/high skill careers, e.g. engineering, computer software engineering, advanced manufacturing, nursing, physicians, marketing, banking, etc. Students will begin their professional network with business partners and mentors, therefore jump-starting their career all before they enter college.

In 2014, Missouri University of Science and Technology reached a master research agreement with Boeing that allows the two organizations to work more closely on research projects for the aerospace company. Boeing has also established an office at Missouri S&T. The collaborative research between Boeing and S&T over the past several years has resulted in advances in many areas, from non-chrome paint primers, to advanced machined product technologies, to machine metrology. Boeing and Missouri S&T's long-standing relationship extends back to the 1960s, when former aerospace company McDonnell Douglas, which merged with Boeing in 1997, helped the university establish an engineering graduate

program in St. Louis in 1964. Boeing also worked with Missouri S&T to create the Center for Aerospace Manufacturing Technologies on campus in 2004. <https://sites.google.com/a/mst.edu/camt-iab/>

Center for Intelligent Maintenance Systems at Missouri University of Science and Technology provides opportunities for cooperative research between Missouri S&T researchers and industrial partners for the purpose of developing technologies in monitoring/diagnostic/prognostic tools for industrial applications. The center has partnered with such companies as Caterpillar, Chevron, Honeywell, and Boeing. It serves as a U.S. center of excellence for the development and transition of innovative advanced technologies for the aerospace manufacturing supply chain. <http://ims.mst.edu/>

The Emerson Center for Engineering Manufacturing at St. Louis Community College is a 31,000-square-foot facility featuring state-of-the-art tooling and equipment and 14,000 square feet of laboratory space and classrooms. The Center has labs for manufacturing, materials, quality assurance, civil engineering, electrical/electronic, CAD & design, and skilled trades. The center provides training programs to support major companies in the St. Louis region, including Boeing, Ameren, and AT&T.

Missouri is a world leader in aerospace and automotive manufacturing, and exports more than \$13.7 billion in manufacturing products to nearly 200 countries every year.

The U.S. is the world's largest aerospace producer, and Missouri has a rich history in aviation. From Charles Lindbergh, to the Mercury space program, to the latest in aerospace innovation by Boeing, Missouri has led the way in every aspect of aviation for nearly 100 years.

Today, Missouri talent builds the F/A-18, EA-18, and F-15 fighter jets, the T-7A trainer jet and the MQ-25 unmanned refueler at Boeing's Defense, Space and Security facilities, along with a huge array of military ordinance.
